2022 was our initial measurement year. The 2023 measurements are not complete due to our financial year end.

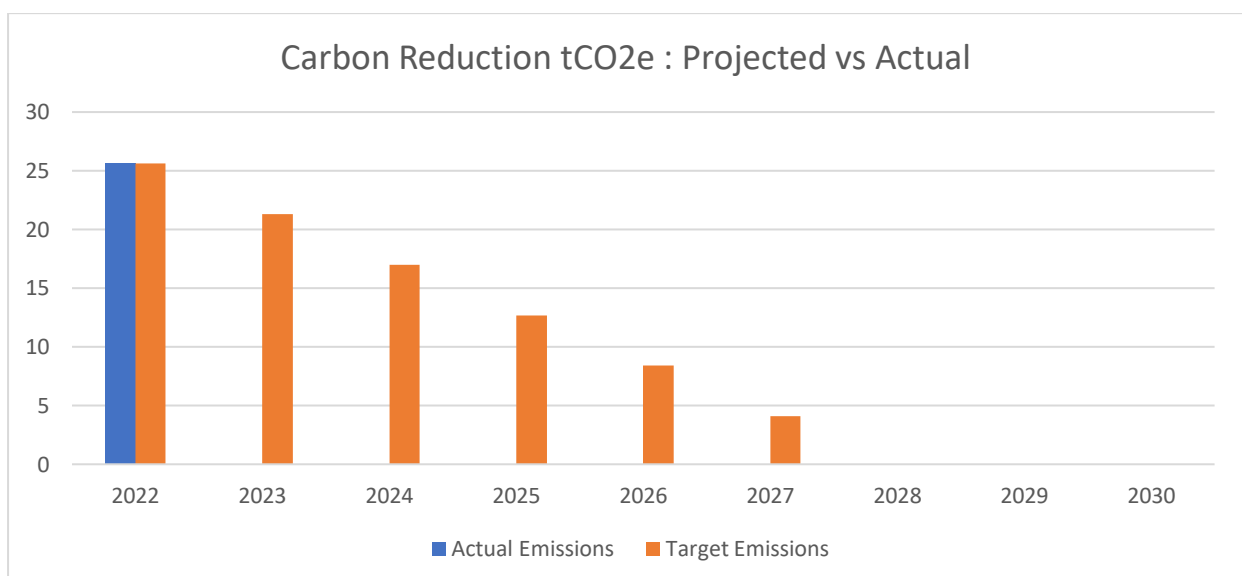

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 0 tCO₂e by 2028. This is a reduction of 100%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 0 tCO₂e, a 0%ge reduction against the 2022 baseline and the measures will be in effect when performing the contract.

- We have moved 95% of our client meetings on-line.
- Introduced solar panel incentives for employees to reduce their personal and work from home emissions.

In the future we hope to implement further measures such as:

- Move all online services to suppliers powered by renewable energy.
